

Exolon Group S-Line, the standard product line, represents a range of certified quality products which offer the reliable solution for most applications.

When using **Exolon® multi UV 7/25-14** in roof or wall installations, the forces exerted by snow and wind loads must be absorbed by a suitable substructure. We recommend implementing the support distance indicated in the diagram for the respective loads.

The diagram shows the load-bearing capacity of **Exolon® multi UV 7/25-14** (supported on all sides, rebate depth  $\ge 20$  mm) with a standard profile on the longitudinal sides. The load-bearing curves enable the user to calculate the actual load-bearing characteristics of the multi-wall sheets in their support construction.

If the rebate depth is smaller, the support distances should be reduced in accordance with the relevant load. For wind forces alone, the loads are permitted to be multiplied by 1.1


## Load bearing characteristics (determination)\*:

The component resistance (limit state of load-bearing capacity) of **Exolon® multi UV 7/25-14** has been calculated by using test reports on similar products. These values are reference values, adequate safety margins must be observed in addition to these values. The margins are to be assessed on a case-by-case-basis.

In general, experience has proven that a safety factor of 1.3 is adequate with regard to the measured resistance values. This safety factor is included in the load tables and diagram.
